1. **APOLOGIES FOR ABSENCE**

5. **MATTERS ARISING**

Police Report – Minute No 3 refers

The Clerk advised that a speed visor was used on a rational system however there was no site identified in Castle Eden and was currently at capacity. A proven need was required for a fixed speed visor and a suitable location for deployment. The initial capital investment was £6500 and the commuted sum over an 8 year lifespan was approx. £3100. The Parish Council would be responsible for indemnity insurance and its removal.

Following discussion, it was **RESOLVED** that Councillor B Robertson investigate the costs of solar powered speed visors.

County Councillors Report – Minute No 6 refers

The Clerk had written to the MP Grahame Morris asking for his support of in the reduction of the street lights proposals following a suggestion from a resident.

Councillor Crute commented that he was pleased with the number of responses he had received regarding the removal of the street lighting columns.
