

**THE MINUTES OF THE MEETING OF THE  
CASTLE EDEN PARISH COUNCIL  
HELD ON THURSDAY 16 FEBRUARY 2017**

**1. APOLOGIES FOR ABSENCE**

There were submitted on behalf of County Councillor Pounder.

**2. DECLARATIONS OF INTEREST**

There were no declarations of interest

**3. POLICE REPORT**

The Clerk advised that there had been 18 incidents, 11 of which were A19 related. There had been a theft of a tractor which was possibly linked to a report of poachers. A hide believed to be for poaching deer and snare wire had been removed from the dene near to The Castle. A vehicle had also been seized which was believed to be used in the commission of poaching.

A resident had made a further complaint regarding vehicles using Burdon Walk as a turning circle. The police had advised that an offence was not being committed however they would try and have some police presence. Councillor Crute explained that he would contact the highways department too enquire if anything had changed.

**Speed Visor**

Councillor Robertson commented that the mobile visor was solar powered. He would continue to research this option.

**Churchyard**

Councillor Mrs Robertson queried who was responsible for the headstones. The Chair advised that this was the responsibility of the families.

**Crematorium**

Conditions had been attached to the planning application and it was queried what the next steps would be. Councillor Crute advised that he had contacted the planning department regarding the conditions. He had asked about the Traffic Regulation Order and the issues around it. Legal advice had been sought around the decision. The advice received from an external source was that it should not be pursued as the Council would have to prove that the planning inspector broke some law for the challenge to be successful.

6. **COUNTY COUNCILLOR'S REPORT**

Councillor Crute had spoken to the highways department and the unauthorised signs in The Village should be removed in the next few days.

Councillor Turnbull explained that there was a lot of littering near the turning circle and rubbish dumped next to the bin. He queried if a fly tipping camera could be used in that location.

Councillor Martin explained that his bin which is now collected from the end of the road was contaminated with fragranced white bags with nappies in. Councillor Crute advised that if the refuse bin was contaminated 3 times in a row, the Council would remove it and refuse to empty bin.
