## 1. APOLOGIES FOR ABSENCE

### 3. POLICE REPORT

There had been 18 reported incidents in the area from 18 May to 14 June 2023, of these incidents, 11 were road or A19 related. There had been 1 report of vehicle crime and 4 ASB relating to noise from the same address.

There had been an escalation in off-road vehicle calls especially over the coastal area recently. They continued to work with DCC and landowners to put in place preventative measures to reduce both risk to pedestrians and prevent access where possible to the larger quads and bikes. Due to Rights of Way prohibitions, it was unlikely that further measures which would block the footpath would be considered and therefore access to the smaller off-road vehicles was extremely difficult to prevent.

The next PACT meeting was at Monk Hesleden Parish Offices (The old Resource Centre), Middle Street on 21st June. The meeting starts at 6pm and usually lasts around 45-60 minutes.

Mrs Moon advised that Police forces had been advised not to chase on public roads.
