

Update on the a19 Junction.

- The U turn signs leading into Castle Eden near Burdon Walk were only advisory signs so people carrying out U-turns were not actually breaking the highway code. He had raised a request to see if they can be changed to the correct enforcement signs
- The a19 Junction, there was an agreement in the planning permission to build the
 new estate in Wingate to improve the road layout. However, this did not need to
 be actioned until the last property on the estate was built. The delay now was due
 to the plans that had been proposed to council had been rejected and the
 highways department were awaiting new plans. He would be working with the
 highways department with this and will keep everyone updated.
